## (2) Curator Certifications

In addition to the credits required for graduation, students must also earn credits as set by the University in accordance with Museum Law Enforcement Regulations. Therefore, those who want to obtain a qualification must systematically take lower courses.

Students in the Faculty of Humanities and Psychology in the Faculty of Literature Education (excluding the Geography and Environmental Studies program) and the Faculty of Life Sciences are required to take electives in history, art history, archaeology, and ethnology.

Students in the Department of Humanities and Education in the Department of Geography and Environmental Studies and the Department of Cultural and Information Engineering in the School of Co-Creation Engineering are required to choose between cultural history, art history, archaeology, ethnography, and geography.

Students in the Department of Food and Nutrition in the Faculty of Science, the Faculty of Life Sciences, and the Department of Human and Environmental Engineering in the School of Co-Creation Engineering must choose from courses in physics, chemistry, biology, and geology.

When you start working as a curator, you must submit a university-issued diploma and proof of credit for courses related to curatorial certification to the appointing body (museum governing body, e.g., provincial or city board of education).

As a rule, curatorial (museum) qualification courses at universities are open to undergraduate students. However, graduate students can also take classes if there is space available. If you wish to apply, please contact the Academic Division. The number of students accepted for training at the museum is about 20 people.

## (c) Japanese Language Teachers

A Japanese teacher is a teacher who teaches Japanese to foreigners who are learning Japanese as a second language rather than as a Japanese tongue. Japanese teachers are people who teach Japanese to people who are learning Japanese as a second language, such as foreigners. With the globalization of society, there is a growing demand for Japanese language teachers to teach Japanese both domestically and internationally. In addition to teaching Japanese language and Japanese culture, Japanese language teachers are also expected to play a role in fostering civic awareness in a globalized society.

In order to complete the program, students must take at least one course from each of the five categories specified in the Agency for Cultural Affairs' "Teacher Training for Japanese Language Education", namely "Society, Culture, and Region", "Language and Society", "Language and Psychology", "Language and Education", and "At least one course of Language and Teaching". A total of 26 credits.

\*The explanation here is different from the Japanese language education sub-program that earns a prescribed 20 credits. Please note that this is different from the qualifications of "Registered Japanese Teacher" listed below.

\*The university is also working on the creation of a national qualification curriculum for "registered Japanese teachers" that will come into effect in April 2024, and is also planning to apply for registration. Applications for registration of the "Japanese Teacher Registration and Training Center" and "Practical Training Center" are about to begin.

As a result of the selection process by the Ministry of Education, Culture, Sports, Science and Technology (MEXT), the scheduled practical training or training course may not be established. Therefore, please check the information provided by the Academic Affairs Department or the Japanese Education Course for program status, courses, and registration methods.

\*By becoming a "Japanese Registered Teacher", you can teach Japanese at a government-approved "Japanese Education Registration Organization". In addition to passing the Japanese language education exam sponsored by a designated testing institution, you must also complete practical training at a registered training institution in order to obtain a national license. However, if Ochanomizu University

becomes a "Japanese Teacher Registered Training Institution" or a "Registered Training Institute", you will be exempted from the "Japanese Teacher Examination" and part of the "Practical Training Course" by completing the prescribed courses.

For students enrolled before 2024, we will implement an educational program in which students earn at least 26 credits in subjects related to Japanese language education based on the current notification standards (formulated by the Immigration Services Agency of the Ministry of Justice on July 22, 2016). Please check information from governments and universities about the future operation of this program and measures to obtain national accreditation.

Students are expected to take at least one course in each of the following three categories: Language and Society, Language and Psychology, Language and Education, and Language. At the request of the student, a certificate of course completion is issued.

However, this certificate is not issued at the request of the student. However, please note that this certificate does not indicate national accreditation or teaching license.

**(d) Certified social researcher and professional social researcher**

**(1) Certification of social researchers**

The social researcher qualification is approved and issued by the Japan Social Research Association and certifies that the certified individual has acquired basic knowledge, skills, applied skills, and ethical awareness related to social research.

Accreditation requires students to study the standard curriculum at an organization or university approved by the Japan Association for Social Studies and to earn a bachelor's degree from a university. In addition, certification as a social researcher is a requirement for certification as a high-level professional social researcher.

At Ochanomizu University, the curriculum is divided into the Department of Geography, Humanities, Psychology Program, Educational Sciences Program, Sociology Program, Faculty of Humanities and Social Sciences, and Faculty of Letters and Education of the Faculty of Arts and Sciences Education. Global Studies for Intercultural Cooperation in the Faculty of Letters and Education; The Department of Human Life Studies in the Department of Developmental Clinical Psychology and the Social Sciences and Family Studies Program, Faculty of Human Life and Environmental Sciences. In order to obtain the qualification of a social researcher, you must obtain the credits required for graduation and take a certified course corresponding to the standard curriculum A to G set by the Accreditation Committee for Social Research in Japan. Students who want to obtain such qualifications must systematically take the necessary courses from an early stage. The specific courses corresponding to the standard curriculum vary for each grade. Additionally, please note that there may be restrictions on G's apprenticeship courses. Details will be provided at the information session scheduled at the beginning of each school year.

**(2) Professional social researcher**

The Professional Social Researcher certification is issued by the Japan Social Research Association and certifies that professional social researchers have advanced research skills.

This qualification proves that the candidate is a professional social researcher with advanced research skills. Our graduate school offers a curriculum that is jointly supported by the MSc Human Development Sciences and the MSc Gender and Social Sciences.

The Graduate School of Social Research jointly organizes the corresponding curriculum.

To qualify as a professional social researcher, students must have an undergraduate-level credential as a social researcher and meet those criteria

To qualify as a professional social researcher, you must be qualified in social research at undergraduate level, complete an accredited course corresponding to curriculum H, I, and J, and write a master's thesis (research thesis) using the results of social research.

The master's program must be completed by writing a master's thesis (research paper) using the results of social research. Students can earn both a bachelor's degree in social studies and a bachelor's degree in professional social studies at the same time.

Students who wish to obtain a qualification must start taking courses systematically at an early stage. The specific courses corresponding to the standard curriculum vary from year to year.

Please note that the specific courses corresponding to the standard curriculum vary from year to year, and some courses are offered every other year. For more information, please contact the Associate Triaison in charge of social research.

If you want to qualify as an undergraduate social researcher at the same time, you must take 10 credits of accredited courses offered by faculty as a non-degree student.

If you want to qualify as an undergraduate social researcher at the same time, you must earn 10 credits from an accredited undergraduate course and become a credit-bearing student. The application period for credit auditors is limited, so do your research early and make a plan. In addition, students are required to take undergraduate courses to obtain qualifications.

If you want to become an undergraduate credit student to qualify, please take advantage of the admission and tuition fee waivers.

#### (f) Dietitian certification

Certification as a dietitian can be obtained by taking a mandatory course in the Division of Nutrition and Food Science in the Faculty of Human Life and Environmental Sciences (138 credits required for graduation).

#### (g) Food hygiene supervisors and food hygiene inspectors

Students who have obtained 40 credits or more, combined with 22 credits from groups A to D and group E credits below, will qualify as food hygiene supervisor and food hygiene inspector. These certifications constitute an appointment qualification that indicates that you can take up the assignment if you are hired for the required role.

#### (h) Eligibility for the national examination for registered dietitians

A nationally registered dietitian is a professional who provides nutritional management for specialized disease treatment based on the nutritional evaluation and evaluation of patients at medical institutions, provides professional nutritional guidance for health promotion at medical institutions, and performs dietary management that requires special consideration according to the nutritional status of users. Etc. You will take the required courses in the Department of Nutrition and Food Sciences (Faculty of Human Life and Environmental Sciences) (earn 138 credits required for graduation) and be eligible to take the national exam.

#### (i) Eligibility for the National Examination for Architects

Architects are professionals who are engaged in building design, construction management, etc. It is a national certification based on the Architects Act. Courses that are part of the curriculum (core program + reinforcement program, sub-program) of the Department of Ergonomics at Ochanomizu University are recognized as architecture-related courses by the Ministry of Land, Infrastructure, Transport, and Tourism. Students outside the Department of Human-Centered Engineering can also qualify for the national exam.

##### **A student in the Department of Human-Centered Engineering, an interdisciplinary engineering department.**

- If you graduate with the number of credits required for the Class 1 Architect Exam, you will be eligible to take the Class 1 Architect Exam. (Depending on the number of credits earned, you will need 3 years of work experience or 2 to 4 years to register as a Class 1 Architect.)
- For the "Architect National Examination Qualification Course (1st Year Architect National Examination Qualification)", please refer to the credit acquisition requirements, required credits, and required practical experience.

##### **○ Qualifications for the national examination for class 2 architects**

Students who enter the Department of Ergonomic Engineering and graduate with the number of credits required to qualify for the Level 2 Architect National Examination can qualify for the Class 2 Architect National Examination. (The required period of work experience ranges from 0 to 2 years, depending on the number of credits earned.)

For the "Course for Qualification for the National Examination for Architects (Qualification for the National Examination for Architects in Class 2)", please refer to the information on the requirements for obtaining credits, required credits, and required work experience.

##### **Students outside the Department of Human-Centered Engineering participate to take the national exam for second-year architects**

Students who study at the Department of Ergonomic Engineering, complete an interdisciplinary program, and have obtained at least the number of credits required to qualify for the National Exam for Architects of Class 2 according to the conditions and are eligible to take the National Exam for Architects of Class 2 will be eligible to take the National Exam for Architects of Class 2. (The required

period of work experience ranges from 0 to 2 years, depending on the number of credits earned.) )

For the "Course for Qualification for the National Examination for Architects (Qualification for the National Examination for Architects in Class 2)", please refer to the information on the requirements for obtaining credits, required credits, and required work experience.

○ **Qualifications for the national examination for class 1 architects (for students outside the department)**

**The School of Human-Centered Engineering wants to qualify for the National Exam for Class 1 Architects.**

If students outside the Department of Human-Centered Engineering want to qualify for the national examination for class 1 architects, the individual certification system of the Ministry of Land, Infrastructure, Transport and Tourism is used. However, please fully consider that students must apply on their own and may not be certified in some cases. (Please consult with the faculty of the Department of Human-Centered Engineering in advance.) )

The course on the qualifications for the National Examination for Class 1 Architects, the requirements for obtaining credits, the required credits, and the required practical experience are the same as those related to the qualifications for the National Examination for Class 1 Architects in the Department of Human-Center Engineering, Faculty of Interdisciplinary Engineering. For more information, please refer to the "Course for Qualifications for the National Examination for Architects (Qualifications for the National Examination for Class 1 Architects)".

The course requirements are strict, making it difficult for non-human-centered engineering students to be trained to qualify for the national exam for Class 1 Architect or Class 2 Architect.

Students who want to qualify for the exam should remember to consult with the faculty of the Department of Human-Centered Engineering in advance

**(j) Accredited Psychologist**

A licensed psychologist is a nationally licensed psychologist who provides counseling and assistance to people in need of psychological assistance and related people. At the undergraduate level, you must master all 25 subjects

At the undergraduate level, you must complete all 25 subjects that are mandatory nationwide to be eligible to take the exam.

The university offers a total of 25 courses, some of which are limited.

However, some of these courses are limited, so only students from the Faculty of Life Sciences Department of Psychology are eligible to take the exam. Below is a list of courses offered at the university.

#### (k) Clinical psychologist

After passing the certification exam, clinical psychologists obtain a license from the Japan Clinical Psychologist Accreditation Board (JCBP). The Developmental Clinical Psychology course has been designated as a Type 1 graduate school by the Japan Clinical Psychologist Accreditation Committee since 2001. Students on this course are eligible to take the Clinical Psychologist Certification Examination after completing at least 16 credits from each of the required subjects (10 subjects offered at the University) and 2 elective compulsory subjects (ABCDE group) for a total of at least 10 credits. Students in other courses can only take classes in the ABCD group.
